## AWARDS

**Rally:** Qualifying ribbons, X Qualifying ribbons for scores 195 or higher, placement ribbons First through Fourth places. High in Trial, High Combined, High Scoring Aussie, High Scoring Other Breed and High Scoring Junior.

**Obedience:** Qualifying ribbons, placement ribbons 1<sup>st</sup> through 4<sup>th</sup> places. High in Trial, High Combined, High Scoring Aussie, High Scoring Other Breed and High Scoring Junior.

- THERE SHALL BE NO REFUNDS for entries withdrawn after the pre-closing date or in the event a dog and/or handler are dismissed from competition, regardless of the reason for dismissal. Bitches in season may receive 50% refund if notification in writing or by email is received before the trial begins.
- There will be no refunds for entries in the event a dog and/or handler is dismissed from competition, regardless of the reason for such dismissal.
- No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
